Tax Update

Revised Filing Fees for Applications Filed under the Puerto Rico Incentives Code

On January 28, 2021, the Office of Incentives for Businesses in Puerto Rico ("OI") published Informative Bulletin No. 2021-001 ("BI 21-01") establishing revised filing fees for applications to be filed under the Puerto Rico Incentives Code ("Code"). Pursuant to Article 6020.01(b)(3)-1 of the regulations issued under the Code ("Incentives Regulations"), filings made on or before January 19, 2021 shall be subject to the filing fees in place before the effectiveness of the Incentives Regulations.

Beginning on January 20, 2021, applications filed through the Ol's Single Business Portal, or through the previous platform at oeci.pr.gov, shall be subject to the revised filing fees detailed below. Applications filed after January 19, 2021, for which the full amount of the revised filing fee and service fee are not included, will be subject to payment rectification for the application to be deemed duly filed.

The following table includes some of the revised filing fees. The service fee for all transactions continues to be \$5.00.
